

The Extraordinary Test-Drive Contest

TERMS & CONDITIONS

A. General

- 1. The Extraordinary Test-Drive Contest (hereinafter referred to as 'Contest') is organised by TC Subaru Sdn Bhd (Company No: 600193-M). (hereinafter referred to as the 'Organiser').
- 2. The Contest commences on 20th September 2021 (Monday), 9:00AM and ends on 31st Dec 2021 (Friday), 11:45PM (hereinafter referred to as the "Contest Period"). The registration and test drive must be completed within the Contest Period.
- 3. The Contest is subject to the terms and conditions stated herein and the Organiser reserves the right to vary, add, modify and / or alter these terms and conditions as and when it deems fit. Such variations may be communicated through modes of communication deemed suitable by the Organiser.
- 4. By participating in the Contest, the participant declares that he / she is deemed to have read, understood, agreed and accepted the terms and conditions herein and agrees to be bound by the same.

B. Eligibility

- 1. The Contest is open to (i) all individual (Private Individual) (ii) aged 18 and above with valid driving license; and (iii) is a holder of a Malaysian Identification Card or (iv) expatriates or holding valid working pass in Malaysia at the time of participation.
- 2. The Contest is not open to members or employees or immediate family members of the Organiser and its related and/ or associated companies, advertising companies, its agents or anyone else connected to the administration and execution of the Contest.

C. Mechanics

- 1. To participate in the Contest, the participant shall take the following steps:
 - a. Participant will need to schedule a test-drive via Subaru Asia website (https://www.subaru.asia/my/en/promotions/sales/411/forester-extraordinary/) or (https://www.subaru.asia/my/en/promotions/sales/410/xv-gt-bold/) or walk-in to any Subaru showroom in Malaysia during the contest Period.
 - b. Proceed with the test drive within the Contest Period.
 - c. Take a video of their test drive experience with the XV or the Forester in his/her preferred language of either English, Bahasa Malaysia or Chinese or a photo with the XV or the Forester after their test-drive.
 - d. The video or photo must be shot during their visit to any Subaru showroom in Malaysia from September December 2021.

- e. Upload and post the video or photo together with a short caption sharing his/her testdrive experience on their personal Facebook account and tag @subaruasiamy and #SubaruTestDrive
- f. Set his/her Facebook post to public.
- g. Visit Subaru Asia website and click on (https://bit.ly/3keuQ8u) to fill up the Contest form.
- h. Participant will need to fill in their name, mobile number, email address and home address and to ensure that all information submitted are valid and accurate.
- i. Insert the link to his/her Facebook Post to the Contest form by the 30th/ 31st (the respective month's last day) of the month throughout the Contest Period.
- 2. Each Participant with the same IC number (for Malaysians) or passport number (for non-Malaysians), is allowed to submit or post as many videos or photos throughout the Contest Period.
- 3. If any information submitted to the Contest site is found to be incomplete, misleading or inaccurate, the respective entry shall be deemed invalid.

D. Prize

Participants who only submits his/her test-drive video or photo will stand a chance to win a "Special Prize" while participants who submitted his/her test drive video or photo, booked and registered either a Subaru XV or Subaru Forester will stand a chance to win a "Premium Prize". The participant must hold the same IC number (for Malaysians) or passport number (for non-Malaysians) when submitting for test-drive, booking and registering the XV or Forester.
- 3. For participants who booked or registered the vehicle under his/her company must show proof that he/she is listed in the company business registration forms.
- 4. Twelve "Premium Prize" winners will be selected from a digital lucky draw every month from September December 2021 and one hundred fifty "Special Prize" winners will be selected from a digital lucky draw every month from September- December 2021.
